- 2) Sealed quotation should reach in this office on or before **18/01/2025** through **Speed Post/By hand** and the Quotations will be opened on **20/01/2025 at 12.30 PM** in the office chamber of the undersigned in the presence of committee members.
- 3) The intending bidders have to deposit **EMD of Rs 10,000/-** (Rupees Ten Thousand only) by way of Demand Draft payable in favour of the **Executive Officer, Choudwar Municipality.** The EMD of unsuccessful bidder will be refunded.
- 4) Bidder(s) can inspect the articles/scrap items between **10.00 a.m. to 3.00 p.m.** in the above-mentioned address from **08/01/2025 to 10/01/2025** in regard to the conditions, quality etc of the articles/scrap items and satisfy themselves before submitting their offer by the date and time specified.
- 5) After inspection of items bidder should quote a price or an amount which he is ready to pay for the scrap offered for sale in a sealed bid. All articles/items will be sold on **"AS IS WHERE IS BASIS"** (both lot wise and item wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/scrap items proposed to be auctioned.
- 6) The Bid shall accompany with Paper cost (Non-refundable) of **Rs 1000/- (Rupees One Thousand Only)** in shape of Demand Draft payable in favour of **Executive Officer, Choudwar Municipality.** Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf. A copy of such authority should be enclosed along with the bid.
- 7) The Bid forms are not transferable.
- 8) Any tax is liveable shall be paid by the successful bidder.
- 9) The successful bidder will be required to make full payment of bid by way of Demand Draft in favour of **Executive Officer, Choudwar Municipality** after the finalization of the bid.
